

Introduction

Powder Horn is based on the Venturing Ranger Award requirements and exposes participants to select outdoor/high adventure activities and the resources necessary to operate a successful High Adventure program.

- Helps Venturing leaders and Scouters to safely conduct outdoor activities of a fun and challenging nature.
- Provides leaders an introduction to the resources necessary to successfully lead their youth through a program of high adventure.
- Familiarizes leaders with the Ranger program so that they can help Venturers to meet the requirements of the Ranger Award.

The course includes all 8 Ranger Core Requirements: Communications, Conservation, Cooking, Emergency Preparedness, First Aid, Land Navigation, Leave No Trace, and Wilderness Survival.

As well as 10 Electives from the following: Backpacking, Cave Exploring, Cycling/Mountain Biking, Ecology, First Aid, Fishing, Hunting, Lifesaving, Mountaineering, Outdoor Living History, Physical Fitness, Plants and Wildlife, Project COPE, SCUBA, Shooting Sports, and Watercraft.

(No participant has to participate in any activity in which they feel uncomfortable.)

Camp La No Che is located in Central Florida about 40 miles north of downtown Orlando.

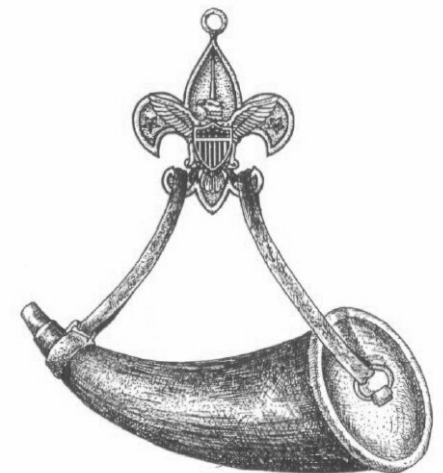
With recent upgrades to facilities, Camp La No Che is an ideal location for Powder Horn.

What is Venturing?

- Co-ed youth program (Ages 14-20)
- Programs are oriented around youth development, leadership, and outdoor skills.
- Youth are supported by adult advisors who help them design and manage their program.
- Venturing members do not have to have experience as a Boy Scout.
- Venturers can participate in activities that Boy Scouts cannot.

Course Participant Qualifications

- Be a registered adult member of the Boy Scouts of America.
- Participants must submit a Class III Medical Form signed by a physician within the past 12 months.
- Have completed basic Venturing Training prior to attending:
 - New Leader Essentials
 - Position Specific Training
 - Venturing Youth Protection
- Be prepared to participate in the course activities. Prepare to have two weekends of fun in the outdoors.

- Introduction to the skills and certifications necessary to operate a high adventure outdoor program
- How to obtain resources and consultants for high adventure activities
- Knowledge of BSA rules and regulations governing health and safety of outdoor programs
- Knowledge of the Ranger and other Venturing awards
